pension income	A document that shows the amount of pension received in any one month after January 2023 (notice of pension determination, notification of revision of pension amount, notification of pension transfer, etc.). *If you do not have the one for that month, the most recent pension amount revision notice is also acceptable.	
Business income or real estate income	A copy of a document that shows the amount of income, such as a copy of a ledger or final tax return
